

1. Introduction

2. Logo

At the beginning of the project, the consortium immediately developed a graphical identity for the AgriBIT project, by designing its logo. The project logo (Figure 1) consists of two banners that represents the wi-fi interconnection (Figure 2) and the leaves (Figure 3) that recall the application domain.

The colour's selection aims at referring the greener agricultural landscape. The colour green is associated with meanings of growth, safety, fertility, and environment. A clear compact and highly legible character has been adopted.

3. The AgriBIT website

3.1. Concept and Approach

The AgriBIT website (<u>https://h2020-agribit.eu/</u>) has been developed at the beginning of the project and was made accessible to public in September 2021 (M3). This initial version of the website includes a short description of the project and its objectives, the consortium partners, the emblem of the funding authority and the acknowledgement text. It has been designed to represent the project in a complete, transparent and user-friendly manner. The website's design has been carefully selected to follow AgriBIT's brand identity to create a well recognisable visual pattern while browsing among the project's information. The website includes several dedicated sections in order to be as complete as possible.

3.2. Site Map

AgriBIT website's high-level structure has been created to display information about the project in a transparent and accessible manner. For reader's ease a depiction of the site map is provided in Figure 1. The comprised elements are presented in detail at the sections that follow and will be updated and enriched during all the project duration.




Figure 5 AgriBIT home

3.2.2. About

The Pilots section give the access to dedicated pages to know and deepen the three pilots foreseen by the project.




Figure 9 AgriBIT Pilots section

These three separated pages for Greece, Portugal, and Italy are presented respectively inFigure 10, Figure 11, and Figure 12. For each one of the pilot, the context, the challenge value, and the piloting focus are introduced.



Context

The pilot test case in Greece, will take place in Pella Municipality, Central Macedonia Prefecture and with Agricultural Cooperative of Pella (ACP) as piloting user. ACP is the 3rd largest cooperative in Greece and has over 10.000 active members growing different type of crops including orchards, cotton and cereals in a total area of 60.000 ha, with the most important being peaches. ACP owns an 8,193m2 Modern Canning Industry and its peach production is exported all over the world.

Context

CCTI operates a tomato field plantation located in the Lezíria do Ribatejo, Portugal. Tomato production covers 1300 ha and is organized in lines of plants separated every 1,5 m apart and with 35 cm distance between plants in the same line. Tomato monocultures are attacked by diseases and pests; in 2018, the main diseases included mildew, bacterial spots (diseases), mites and tuta absoluta (pests). The actual list of diseases changes every year and spread very fast during the crop growth period.

Context

Pilot on grapevine (Vitis vinifera L.) will be conducted in high-plant-density vineyards, located in Umbria (Central Italy), for the production of high quality red and white wine. The vineyards area involved extends over 200 ha with plants warping of $0.9 \text{ m} \times 2 \text{ m}$ (5550 plants / ha). The area is managed by a group of farms that are involved through partner Agricolus.

From each news, it is possible read the complete text by clicking on the "Read more" button.




Figure 14 AgriBIT News section




Figure 15 AgriBIT example of news
